## CONSENT OF DIRECTORS IN LIEU OF SPECIAL MEETING

The undersigned, being all of the members of the Board of Directors (the "Board") of **Seattle Internet Exchange**, a Washington nonprofit corporation ("the Corporation"), hereby agree and consent to the following corporate actions in lieu of holding a special meeting, pursuant to RCW 24.03.465 of the Washington Nonprofit Corporation Act (the "Act"):

WHEREAS, it has recently come to the attention of the Board that the name of the Corporation was corrected by the Office of the Secretary of State, to remove the corporate ending of "Inc." in accordance with RCW 24.03.120 of the Act, following filing the Articles of Incorporation of Seattle Internet Exchange, Inc., without its knowledge;

WHEREAS, the Corporation has held multiple Board meetings over the course of several days, which have been conducted online asynchronously via email (not synchronized; that is, not occurring at predetermined or regular intervals), amongst the Board, since its incorporation in 2001;

WHEREAS, minutes of the online asynchronous meetings have been prepared, approved and maintained by the Corporation, which minutes accurately reflect all actions taken by the Board via email and the dates of such meetings are listed on <u>Exhibit A</u> attached hereto, which minutes, in addition, show the name of the Corporation as Seattle Internet Exchange, Inc.;

WHEREAS, it has recently come to the attention of the Board that RCW 24.03.120 of the Act requires that ". . . members of the board of directors or any committee designated by the board of directors may participate in a meeting of such board or committee by means of a conference telephone or similar communications equipment by means of which all persons participating in the meeting can hear each other at the same time and participation by such means shall constitute presence in person at a meeting"; now, therefore, it is hereby

RESOLVED, that in order to comply with the Act, the Board hereby ratifies, approves and confirms any and all actions taken by the Board, online asynchronously via email, since incorporation;

FURTHER RESOLVED, that all references to Seattle Internet Exchange, Inc. in Minutes of the Board of Directors Meetings and Minutes of Annual Meetings of members, shall refer to Seattle Internet Exchange, the name shown on the records of the Secretary of State;

FURTHER RESOLVED, that these resolutions shall be retroactive and shall act as a ratification of all actions taken by the Board before the date of adoption of these resolutions;

FURTHER RESOLVED, that the appropriate officers of the Corporation are authorized to execute all such instruments and documents, if any, and to take such other actions as they may deem

necessary or desirable, to effect the intent and purposes of these resolutions, and such actions previously taken by an officer are hereby ratified, confirmed and approved.

FURTHER RESOLVED, that this Consent may be executed in any number of counterparts and may be transmitted by facsimile. All of such counterparts together, whether original or transmitted by facsimile, shall constitute one and the same instrument.
